VII-1. Mechanical Engineering Technology, BSET with grad track option leading to Mechanical and Energy Engineering, MS (Requested exception yr.: 2025-26)

Justification: This grad track pathway provides the opportunity for any qualified Mechanical Engineering Technology Bachelor's (MEET-BSET, 122 SCH) student to complete a Mechanical and Energy Engineering Master's (MEEN-MS, 30 SCH). Students can transfer up to 9 graduate credits from their MEET-BSET degree to MEEN-MS program, for a combined minimum total of 143 SCH. Additional leveling courses for students not having an undergraduate degree in the destination department may be required and not count towards the graduate degree plan. Qualified students have a minimum 3.5 GPA.

VII-2. Emergency Administration and Planning, BS with grad track leading to Emergency Management and Disaster Science, MS

Justification: Our department seeks to provide a grad track pathway to outstanding undergraduate emergency management students to complete both a Bachelor of Science in EADP and a Master of Science in EMDS in five years. Students would first earn a bachelor's degree in EADP and then a Master's in EMDS. Given our undergraduate curriculum and the department's ongoing commitment to balancing theory and practice when delivering our undergraduate courses, we feel exposing advanced undergraduate emergency management students to disaster science (e.g. the science that guides emergency management practice), during their last two semesters of study not only prepares them for high-level positions in the emergency management field, but it will offer them a well-rounded education in both areas.

Additionally, students on the Grad Track Pathway would seamlessly satisfy the requirements for the undergraduate degree while also providing them an opportunity to move efficiently through their graduate studies. Given the increasing demand for emergency managers with master's degrees for many government employers (e.g. FEMA, Texas Dept. of Emergency Management, many local emergency management offices

in large US cities) in addition to the rapidly growly private and nonprofit sectors, this degree would make these students more competitive in an evolving job market.

MGMT 5870 and MGMT 5900 have also not been taught in this degree for some years and will be replaced with BUSI 5520 Industry Visits and BUSI 5510 Management Innovation and Creativity. VIII-8. Construction Engineering Technology, BSET with grad track option leading to Engineering Management, MS (change in requirements; change in hours; clarity)

Justification: Requirements -courses that can be selected for the grad track program- are being updated. Required SCH for the Master's in Engineering Management is being reduced from 33 to 30 SCH. Therefore, students can still transfer up to 9 graduate credits from their CNET-BSET degree (123 SCH) to EMGT-MS program (30 SCH), but their combined minimum total of SCH will now be 144 SCH.

VIII-9. Construction Management, BS with grad track option leading to Engineering Management, MS (change in requirements; change in hours; clarity)

Justification: Requirements -courses that can be selected for the grad track program- are being updated. Required SCH for the Master's in Engineering Management is being reduced from 33 to 30 SCH. Therefore, students can still transfer up to 9 graduate credits from their CONM-BS degree (120 SCH) to EMGT-MS program (30 SCH), but their combined minimum total of SCH will now be 141 SCH.

VIII-10. Mechanical Engineering Technology, BSET with grad track option leading to Engineering Management, MS (change in requirements; change in hours; clarity)

Justification: Requirements -courses that can be selected for the grad track program- are being updated. Required SCH for the Master's in Engineering Management is being reduced from 33 to 30 SCH. Therefore, students can still transfer up to 9 graduate credits from their MEET-BSET degree (122 SCH) to EMGT-MS program (30 SCH), but their combined minimum total of SCH will now be 143 SCH.

VIII-11. Mechanical and Energy Engineering, BS with grad track option leading to Engineering Management, MS (change in requirements; change in hours; clarity)

Justification: Requirements -courses that can be selected for the grad track program- are being updated. Required SCH for the Master's in Engineering Management is being reduced from 33 to 30 SCH. Therefore, students can still transfer up to 9 graduate credits from their MEEN-BS degree (127 SCH) to EMGT-MS program (30 SCH), but their combined minimum total of SCH will now be 148 SCH.

VIII-12. Mechanical and Energy Engineering, BS with grad track option leading to Mechanical and Energy Engineering, MS (change in requirements)

Justification: Grad track program requirements (courses that can be taken) are being updated since the requirements of the Mechanical and Energy Engineering, MS program are updated. The change will provide grad track students more flexibility in selecting graduate courses.
