### III-1. Teaching, MEd - Action Item/ Information Item

Proposal: <u>https://unt.curriculog.com/proposal:6315/form</u> was approved during June 2019's agenda with an effective date of Spring 2020. This information item is to update the effective date to Fall 2019. The department would prefer to immediately begin redrawing certain degree plans for students to move to the 30-hour degree program if the student is agreeable to the change.

### Justification:

- Reducing the number of hours from 36 hours to 30 hours will save students time to complete the degree.
- Reducing the number of hours from 36 hours to 30 hours will save students money and make the program more competitive.
- Reducing the number of hours will not affect the quality of the program.
