IV-4. INFO 5742 - Web Archiving

Description: The web is a fundamental component of nearly all modern interaction. Preserving content from the web and providing long-term access to preserved content presents an interesting set of challenges for Information Scientists. You develop knowledge and skills related to the standards, tools, and processes of web archiving. You learn the mechanics of web archiving and its relation to familiar concepts like collection building and appraisal, access and use, and ethics. This course provides hands-on experience working with

different projects and tools, and is designed for anyone interested in the topic without any need for prior experience in web archiving.

- IV-5. [INFO 5446 - Library Program Development with Learning Sciences](#)** (requested exception yr.: 2023-24;
Rationale: Course Developed as INFO 5960 and run for 3 years; Approved by CLEAR)

Description: Learning sciences is an interdisciplinary field that works to further understanding of learning across settings, in both formal and informal environments. Students will explore theories of human development and learning, current research into the learning lives of people in a variety of situations, and methods of improving services through design-based implementation research. By the end of this course, students will be able to identify and apply effective tools and practices to support learners of all ages in pursuing their goals via library programs and services.

- V-1. [Secondary Education teacher certification](#)** (add) (requested exception yr.: 2024; Rationale: none provided)

Justification: The STEM faculty in the department of Teacher Education and Administration want to provide individuals seeking mathematics, science, and/or engineering teacher certification with an opportunity to collaborate with each other on an integrative STEM curriculum. Dr. Eddy consulted with the current Associate Dean, Dr. Alex Leavell beginning in Spring 2022-Fall 2022 about the change who then said that approval was needed by the STEM faculty to make the change. Stem faculty met on October 13, 2022, and decided on the one course, EDCI 5340 being required by individuals seeking mathematics, science, and engineering teacher certification. This impacts individuals seeking certification in the post-baccalaureate program.

V-2. Interdisciplinary Studies with a concentration in Applied Analytics, MA (delete)

Justification: Deleting this concentration and retaining the parallel concentration in the MS. This will allow all INSD MS degrees to have a STEM CIP and only NSD degrees with a concentration that is a STEM CIP to be in the MS.

V-3. Interdisciplinary Studies with a concentration in Applied Gerontology, MS (delete)

Justification: Moving to INSD MA degrees having non-STEM CIP and INSD MS degrees having STEM CIP. This concentration is not eligible for a STEM CIP so the MS in this concentration is being deleted and the MA being retained.

V-4. Interdisciplinary Studies with a concentration in Digital Social Science, MA (add)

Justification: Concurrent with the deletion of the Digital Social Science concentration of the MS in INSD is the creation of the Digital Social Science concentration for the MA in INSD. The goal here is to consolidate STEM CIP eligible concentrations in the MS and non STEM CIP eligible concentrations in the MA degree.

V-5. Interdisciplinary Studies with a concentration in Digital Social Science, MS (delete)

Justification: Deleting the Digital Social Science concentration in the MS in INSD. Will simultaneously be creating the Digital Social Science for the MA in INSD. This is part of a consolidation of the STEM CIP eligible concentrations in the MS and the non STEM CIP eligible concentrations in the MA of INSD.

V-6. Interdisciplinary Studies with a concentration in Fitness Management, MS (delete)

Justification: Deleting concentration per conversation with Kinesiology, Health Promotion and Recreation Chair, Jakob Vingren. Concentration had not seen significant enrollment and no longer serves needs.

V-7. Interdisciplinary Studies with a concentration in Geospatial Intelligence, MS (add)

Justification: This new concentration provides much needed pathways in a growing field.

V-8. Interdisciplinary Studies with a concentration in Humanities, MS (delete)

Justification: Deleting Humanities concentration in INSD MS and (re)creating concentration in MA. This is part of an overarching effort to have STEM CIP concentrations in the MS in INSD and non-STEM CIP concentrations in the MA in INSD.

V-9. Interdisciplinary Studies with a concentration in Interactive and Virtual Digital Communication, MS (delete)

Justification: Deleting the MS and retaining the MA in the concentration. This is part of an overarching reconfiguration of the MS in INSD to be only for STEM CIP concentrations and the MA for non-STEM CIP concentrations.

V-10. [Interdisciplinary Studies with a concentration in Program Leadership, MA](#) (add)

Justification: The INSD MS concentration is being closed concurrently with the creation of this MA concentration. This is part of a broader effort for MA INSD concentrations to be for non STEM CIPs and MS INSD concentrations to be STEM CIPs.

X-4. DISCI 5330 - Business Intelligence Foundations

Course Title: ~~Enterprise Applications of Business Intelligence~~ > Business Intelligence Foundations

Short Course Title: ~~ENT APPS OF BI~~ > BI FOUNDATIONS

Description: ~~Current issues in the utilization of business intelligence (BI) in business, government, academia and innovation. Topics include the concepts, methodologies and tools to efficiently and effectively implement business intelligence endeavors. Emphasis is placed on current direction of BI as it is relevant to projects underway in business, government and academia across all levels of their value chains. A semester project in the area of BI relevant to a functional area of business is an important component of this course.~~ > An introductory course in business intelligence and its application to support business decision-making and improve business performance. It also provides a foundation for modeling with spreadsheets. The business intelligence and analytics techniques will be applied to business activities in various functional areas such as accounting, finance, marketing, operations, and human resources. The course will introduce and develop excel skills as well as an understanding of key business concepts as well as the business context and use of analytics. Emphasis will be placed on the interpretation of foundational analytic results and meaning in a business decision.

X-5. MGMT 5401 - Talent Management in the Sport Entertainment Industry

Description: ~~Explores the unique managerial issues associated with talent management in the sport entertainment industry. Emphasis is on student application of material and proposing solutions to problems in developing, recruiting and managing talent in the sport entertainment industry. Subjects discussed include talent development programs in youth sports, player evaluation strategies around the world, draft and trade strategies, contract law, mentorship, and career development off and on the field.~~ > Explores the unique managerial issues associated with talent management in the sport entertainment industry. Emphasis is on student application of material and proposing solutions to problems in developing, recruiting, and managing talent in the sport entertainment industry. The course examines the entirety of the talent management life cycle, including attracting talent, hiring processes, effective onboarding, managing workplace dynamics, performance management, leadership development, and succession planning and change management.
