Accomplishments (including items submitted for review or approval to the Executive Committee or Faculty Senate):

CSW Co-Chair Jennifer Lane met with Chair of Committee on the Status of Faculty of Color, Melody White, and Chair of Committee on the Status of LGBTQ+ Faculty, Eddie Meadors, on February 25, 2020 to discuss data requests that the CSW had already made of Provost Cowley (attached to CSW mid-year report), in particular the request for interval data. Provost Cowley had asked that these committees coordinate data requests for which this meeting was the follow-up.

After the COVID-19 pandemic resulted in closure of UNT after Spring Break and Denton County issued then Stay at Home Orders effective 3/25/2020, CSW met on April 24<sup>th</sup> to craft a list of recommendations to the Provost regarding equity in responding to and recovering from the university's closure and transition to entirely online classes. CSW met with Provost Cowley briefly on 4/27 to discuss these recommendations and provided her with a copy of them. That document, dated 4/28/2020 is attached and has been posted to the Committee on the Status of Women webpage on the Faculty Senate Website. Provost Cowley used a number of the CSW's recommendations in her weekly message to Chairs sent on Wednesday 4/29.
