XII-1 NUET 4930- increase in semester credit hours (3 to 4) raises the major requirements of Nuclear Engineering Technology, BSET (not currently accepting students) from 72 to 73 hours.

XII-2 SOWK 3800- decrease in semester credit hours (4 to 3) reduces the major requirements of the Social Work, BS from 55 hours to 54 hours.

XII-3 The pre-business requirements for the BBA and BS degree in the College of Business should be the same; inadvertently, previous UCC submissions for these requirements did not make clear that the changes should be made for all BBA and BS business degrees.
