- Research Assistants funded by UNT/State: State funds will be used to deliver work related product/education to UNT. We will not fund RAs for select faculty.
- **Hiring Freeze**: Exemptions received from Governor's office have been communicated to Deans. We got fewer exemptions that what was requested. Hiring freeze does not apply to local UNT money/summer teaching requirements. However, the hiring of advisors is frozen. Importantly, searches for positions with start dates beyond 09/01/2017 can continue.
- Months of Service Verification: Verification and validation of records are underway to fix errors. This is important to determine vacation time and longevity pay for staff on a 12-month pay. People finding discrepancies are requested to contact Ms. Ruby Raines at the UNT President's Office.
- **Salary Compression**: The new provost will be tasked with conducting a salary study to determine compression, equity, market analysis etc. This will help understand current salary and target salary levels.
- **360 Evaluation**: Current evaluation is statistically meaningless given the poor faculty participation in the process. Proposed a 360 Evaluation of Chairs/Deans/Cabinet Officials,  $1/3^{rd}$  of each group evaluated once every two years. Each evaluation will be done by three groups (i) peer group, (ii) direct-report staff/faculty, and (iii) advisory board (if applicable).
