I-1 Programs at UNT have expressed interest in establishing processes for awarding credit for prior learning that may take place outside the traditional classroom. Policy 06.001 addresses Evaluating, Awarding and Accepting Credit, but does not defined processes in how to evaluate prior learning credit.

As programs consider applying alternative types of learning to degree requirements, it is important that we follow consistent procedures that align with principles of accreditation and UNT policy. A group has been working to draft changes to Policy 06.001 and associated guidelines that outline the process on how UNT can evaluate different types of learning for equivalent UNT credit. Central to all discussions have been compliance with principles of accreditation, creating a streamlined process, upholding the quality and integrity of UNT programs, and maintaining faculty oversight of academic programs.

UUCS is asked to review the draft policy and guidelines (attached) and send comments and questions to Brenda Kihl.
